PUBLIC HEALTH INSURANCE ENROLLMENT ASSISTANCE FOR THE AGED, BLIND & DISABLED (ABD) POPULATION

If you are over 65, living with a disability, blind or visually impaired, we can help you apply for Medicaid and the Medicare Savings Program.

Our Facilitated Enrollers speak many languages and understand your needs. They are located at sites that you trust in your community and can answer questions you may have over the phone. An enroller can also come to your home if you can't come to us because of a disability. They will walk you through the sign up process step by step and will help you:

- Complete your application
- Submit your application to HRA for a decision
- Follow-up on your case
- Assist with Medicaid renewal

If you are turning 65 within the next 3 months or you are 65 years of age or older, you may be entitled to additional medical benefits through the Medicare program. You are required to apply for Medicare as a condition of eligibility for Medicaid. We can help! We have trained Medicare counselors that can provide you with free assistance in applying for Medicare. WHO IS CONSIDERED AGED, BLIND & DISABLED (ABD)?

For this program, you are considered:

Aged: If you are 65 years of age or older

Blind: If you have been Certified Blind by the NYS Commission for the Blind (NYSCB)

Disabled: If you have been Certified Disabled by the Social Security Administration (SSA), State Medicaid Disability Review Team, or local (NYC only) Medicaid Disability Review Team

Not Certified Disabled but Chronically Ill: An individual who is unable to perform at least two activities of daily living such as eating, toileting, transferring, bathing and dressing, or requires considerable supervision to protect from crisis relating to health and safety due to severe impairment concerning mind, or having a level of disability similar to that determined by the State Medicaid Disability Review Team.

HEALTH INSURANCE PROGRAMS COVERED

We can assist with the following programs:

Medicaid: Community Coverage with or without Community-Based Long Term Care Services

Medicaid Buy-In for Working People with Disabilities (MBI-WPD): People with disabilities who are working may have the chance to buy Medicaid health care coverage

Medicaid Excess Income Program (Medicaid Spend Down): Provides coverage to certain individuals with income above the appropriate Medically Needy income guideline

Medicare Savings Program: Assistance to pay for your Medicare Premium

Medicare: We can assist you in applying through the Social Security Administration

WHAT TO PROVIDE WHEN APPLYING

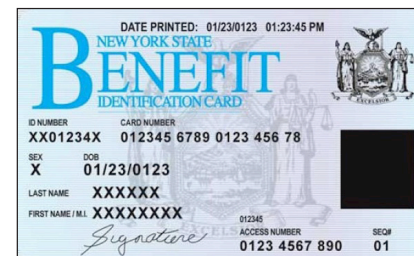
Call ahead to make an appointment and discuss what you will need to bring. But here are a few items you'll likely need:

Medicaid

- Proof of home address dated within 6 months (such as lease agreement, utility bill, postmarked envelope, driver's license, letter from government agency)
- Proof of Citizenship/Immigration Status/Identity (e.g. U.S. Passport, Certificate of Naturalization, Certificate of U.S. Citizenship, Green Card, Employment Authorization Card)
- Proof of current income (such as paycheck stubs, letter from employer on company letterhead, unemployment benefits award letter)
- Proof of current resources (such as bank account statements, IRA – if applying for Community-Based Long Term Care Services)
- If you are certified blind/disabled, proof is required

Medicare Savings Program (MSP)

- Please see above documents that you may need when applying for MSP
- Must be active in Medicare Part A and/or Medicare Part B, and proof of your current insurance if applicable (such as Medicare card)
