MORE THAN 27,000 UNDERSERVED WOMEN AND CHILDREN RECEIVE FOOD AND NUTRITION SUPPORT, INCLUDING FOOD PACKAGES, NUTRITION EDUCATION, BREASTFEEDING SUPPORT AND REFERRALS TO OTHER SOCIAL SERVICES THROUGH PHS' NEIGHBORHOOD WIC PROGRAM, WHICH IS THE LARGEST WIC PROGRAM IN NEW YORK STATE.

PHS HAS CONTRIBUTED TO THE INCIDENCE OF HIV/AIDS IN NYC REACHING AN ALL-TIME LOW SINCE THE START OF THE EPIDEMIC. OUR WORK PROMOTES THE IMMINENT ERADICATION OF AIDS IN NYC THROUGH RESEARCH, SERVICE DELIVERY AND FUNDING ADMINISTRATION. WE ENGAGE OVER 200 COMMUNITY-BASED ORGANIZATIONS AROUND THE CITY IN HIV-RELATED OUTREACH. THROUGH SUBRECIPIENT AGREEMENTS, WE ENGAGE OVER 200 COMMUNITY-BASED ORGANIZATIONS, IN NEW YORK CITY AND THE TRI-COUNTRY TO CONDUCT THE CITY TO PROVIDE OUTREACH AND DIRECT SERVICES.

BECAUSE OF OUR 7 PROGRAMS, PARTICIPANTS ARE BETTER CONNECTED TO SERVICES, HAVE INCREASED POSITIVE PARENT-CHILD INTERACTION, SET AND MEET THEIR PERSONAL GOALS, AND HAVE BETTER HEALTH AND BIRTH OUTCOMES. THE MCH UNIT ALSO OPERATES THE NYC BREASTFEEDING WARMLINE, THE QUEENS DIAPER BANK, QUEENS CRIBS FOR KIDS PROGRAM, AND OTHER SPECIAL PROJECTS, REACHING ADDITIONAL NY FAMILIES WITH SUPPORT SERVICES AND NEEDED BABY ITEMS.
